Code 5 = Temporarily Not Enrolled – Students temporarily in Juvenile Hall/legal or Orangewood/Family Services CDS related reasons.

Note* If the student ends up **not** returning you will dis-enroll. Also may have to adjust this code after the fact if parents did not inform school. CALPADS/IS Dept. may contact you if this happens.

Code 6 = Early Out – Elementary Schools Only – Students who leave early from school (over 30 minutes) for an unexcused reason. (Truant)
